

Agostinho Miranda, ProPública Agostinho Pereira de Miranda is a Founding Partner of Miranda & Associados, an international law firm based in Lisbon and with offices in



14 countries, including 11 in Africa. He is also a consultant and university professor, having lived and worked in London, Houston, San

Francisco, Luanda and Maputo. He recently founded ProPública, an association providing legal and extralegal support to relevant public interests otherwise lacking representation.

Theo Papaioannou, Open University UK Theo Papaioannou is a Professor of Politics, Innovation and Development at The Open University. He is currently the director of Innogen Institute, an interdisciplinary joint initiative between The Open University and the University of Edinburgh. DG for Development and Cooperation at the European Commission.
Reis Conde believes that in order to respond to the increasingly complex challenges in the world around us—ranging from conflicts and migration to climate—change and demographic challenges—

development finance needs to rely on a combination of funding sources. In order to increase their impacts, public and private funding sources must be leveraged as efficiently as possible. This requires the European Union to be agile and stand ready to adapt and develop further its financial instruments and policy tools for investments outside the EU, hereby complementing its traditional development toolbox in order to deliver on its ambitious commitments to sustainable development.

Katarzyna Hanula-Bobbitt, Head of Policy, CONCORD

Europe The Head of Policy and Advocacy at CONCORD Europe focuses on institutional outreach, building strategic alliances and producing policy trend analysis. Before joining CONCORD, she was engaged in advocacy efforts in the wake of the global and European post 2008 crisis regulation agenda in striving to bring taxpayers and citizens interests into the debate. With her background in economics and financial markets, she accompanies the changes in the financing trends including role of the private sector in development financing. As a member of REFIT-the Platform of the European Commission, she worked on several policy areas to achieve better regulatory



efficiency and reductions in administrative burdens.

Within a global framework of financing for development, a significant number of instruments have been developed that go beyond the official ODA classification. In my

intervention, I would like to discuss emerging financial trends that are being used to support development and human rights in the Global South reaching beyond the traditional ODA structure, building on the role of the private sector (sovereign wealth and investment funds), aid for trade instruments, blended finance, the role of development banks, investment impact, etcetera. All of this is serving to create a potential new geography for development finance that NGOs should know how to respond to.

Mark Randazzo, Executive Director, Edge Funders Alliance

Mark has worked to strengthen grassroots organizing, civil society networks and global social movements for over 40 years, working within philanthropy and for non-profit organizations in Africa, Asia, Europe and the US. Mark began coordinating the work of the Funders Network on Trade and Globalization from San Francisco in 2001 and led a merger with Grantmakers without Borders to form EDGE Funders Alliance in 2012. Mark will discuss the emerging debates and developments that advance an alternative "systemic change philanthropy," that - informed by en-

gagement with civil society and social movement efforts to strengthen systemic alternatives - moves from trans-



actional to transformational grant making in support of deep and long-term societal change.

work at ActionAid and was a European Policy Director for the ONE campaign.
Laura will discuss her current work in shaping sustainable markets at the IIED and focuses on private sector engagement for the achievement of the SDGs.

Mariana Abrantes de Sousa, Vice President, TESE Development Association graduated in Economics and Public Policy from the University of California, Berkeley and Princeton University. She worked for 10 years as a Financial Consultant in emerging countries and 25 years as a bank manager with The Chase Manhattan Bank in the United States and with ABN AMRO

(Portugal). She served for four years as Financial Controller in the Ministries of Transport and Health.

Throughout his career, she has carried out consultancy work



financed by multilateral organizations (EBRD, European Commission, Bizclim, African Development Bank, Government of Angola, ELO / IICT, IMF / FAD, USAID, KfW and BPC) in several countries.

Until recently, she served as non-executive director of the Infrastructure Crisis Facility (PIDG). She teaches at the UNL - Nova School of Business and Economics.

Mariana Abrantes de Sousa is going to provide us with her perspective on the private's sector contribution to development innovation and on how civil society organizations build bridges with the private sector and putting forward the example of a Portuguese NGDO.

Any innovative process must place learning at the center of organizational development practices, embracing complexity and uncertainty, observing and reflecting on the relationships between the parties, the spaces between the different organizational members from which the structure, culture, and the form as a whole manifests itself.

Paolo Mefalopulos, Chile
Country Office Representative,
UNICEF Paolo Mefalopulos has
been the UNICEF Representative

in Chile since July 2018. He came from Uruguay where he had been the representative since 2014. Previously, he was Chief of Communication for the UNICEF India Country Development Program. His professional experiences cover a wide range of communication areas related to social and behavioral change. He worked in the field of information, education and communication with a number of NGOs and international agencies, such as UNESCO, FAO, the European Union, CISP, and the World Bank. His main expertise is in participatory communication research and planning. While working for FAO, Dr. Mefalopulos was part of a team that developed an innovative methodology known as PRCA-Participatory Rural Communication Appraisal. He has also taught courses on media studies and international communication at the University of Texas at Austin, where he obtained his Ph.D. in International Communication.



Paolo Mefalopulos is going to share his perspective on how communication connects and empowers people and its role in supporting a strong and independent media,

capable of educating citizens and raising awareness about the global challenges.

Lola Huete Machado, Director, Planeta Futuro, El País Born in Toledo (Spain), a psychology graduate and an inveterate traveller (step by step, she has already visited more than 120 countries), Lola Huete has been a journalist and reporter for the El País



newspaper since 1992 working in different sections. In 2011, she started a reference blog, Africa Is not a Country, which offers the other side of the continent, the everyday, positive, innovative, musical, literary and traveling side ... In 2014, she became Director of the "Planeta Futuro" branch in El País, an exciting journalistic project, unique in its kind and in Spanish, for Sustainable Human Development eradicating poverty and inequality with the support of the Bill and Melinda Gates Foundation. The project conveys how, every day, everything that happens to another human being, whether near or far, is never foreign to us.

Her presentation correspondingly covers the transforming role of the media; a five-year balance of Planeta Futuro, the sustainable development and poverty section of the El País newspaper; how to do journalism daily and in the field, focusing on the 17 Sustainable Development Goals as well as how to "not die trying" in times of growing populism and xenophobia.

Coordinator, journalist and Deputy Editor in chief of Lusa (Portuguese News Agency), where she started her international career as a journalist almost 19 years ago. Mafalda is Alumni of the Nova SBE and Johns Hopkins University (SAIS).

Juraj Bardy, Managing Partner, Alistia has specialized

in public administrations reform since 2009 and is an expert on digital innovation. Juraj currently works as Managing



Partner at Alistiq - a consultancy that supports governments seeking to increase their capacities and performance through providing high quality services based on data-driven solutions. He proposed and supervised the implementation of the national eHealth solution in Kosovo. To save civil society, we must invest in understanding how digital technologies help to concentrate power and change relationships between sectors and, even more importantly,

how to minimize the negative consequences. Digitalisation is one of the keys and most dynamic mega-trends influencing development today — and yet is often missing from civil society's agenda.

João Nuno Bento, CEO, Nova Base With a 25-year career in Information Technology, the director has founded several business projects while also holding leadership and



University of Lisbon and an advanced management program at the Catholic University / North-

western University - Kellogg School of Management. João Nuno Bento will here illustrate some of the challenges associated with deploying Digital Systems in LDCs. He also addresses the huge positive impacts for these societies from transferring the technologies and processes that high-income economies now take for granted.
